1.0 Release Details

FedMall Release v22.2.1 will go live on January 14, 2022. These notes describe all functional changes and how those changes affect the use of FedMall.

1.1 Purpose

This document captures the functional release notes describing an update to the FedMall system. Except where otherwise noted, this document describes the availability of new or updated functionality in the Production (“PROD”) environment, i.e., available to the generality of FedMall users.

FEDS	Improved the performance of EBS Troop Data Load and FEDS Export Processes.	124677
FEDS	Updated the FEDS FLIS export logic to display blank instead of null for Minimum and Maximum Order Value.	124568
FEDS	This update to FEDS logic is to optimize the system to more efficiently manage FLIS, EBS Troop, and Commercial Supplier Data Files.	124365
FEDS	When changing the time interval for contract exports from FEDS to commerce, it was discovered that the same contracts were being exported every 15 minutes. The export flag is being implemented to prevent duplicates, and only send a contract export if the file contains data.	124701

FEDS	Update to the FEDS logic to assign only the MILSTRIP payment indicator attribute for GSA NSNs.	124652

Commerce Backend Logic	Update the Commerce logic to capture the actual status of permissions (N, A, P, R), instead of capturing “Yes” or “No” if the permission has been requested. This will provide a more accurate representation of the Permission Status in the Monthly All User Report that is generated and sent to DLA.	124665
Commerce Search	Addressed erroneous message on the PDP for equivalent Ability One products.	124982
